Tokyo, Japan (July 1, 2015) – Daiichi Sankyo Company, Limited (hereafter, Daiichi Sankyo) today announced that it has acquired its own shares based on the provisions of Article 156 of the Companies Act as applied by replacing the relevant terms pursuant to the provisions of Article 165, Paragraph 3 of the same act.
