## Daiichi Sankyo Announces Status Relating to Acquisition of Own Shares

(Based on the Articles of Incorporation pursuant to the provisions of Article 165, Paragraph 2 of the Companies Act)

**Tokyo, Japan (February 1, 2018)** – Daiichi Sankyo Company, Limited (hereafter, Daiichi Sankyo) today announced that it has acquired its own shares based on the provisions of Article 156 of the Companies Act as applied by replacing the relevant terms pursuant to the provisions of Article 165, Paragraph 3 of the same act. The status (progress report) of the acquisition is as described below.

1. Class of shares acquired: Ordinary shares of Daiichi Sankyo

2. Total number of shares acquired: 3,201,900 shares
3. Aggregate amount of acquisition cost: ¥ 10,578,879,700

4. Acquisition period: From January 1, 2018, to January 31, 2018
5. Acquisition method: Purchase on the Tokyo Stock Exchange
